Sub: Grant of First Affiliation from the Academic Year 2008-09.

Sir,

As per the provision of section 65 (4) of Maharashtra University of Health Sciences Act 1993 I am directed to communicate the decision of the Academic Council of the University, taken in its meeting held on 29/07/2008. The Academic Council resolved to grant First Affiliation vide its resolution No. 389/2008 to your college viz. College of Physiotherapy, Chinchwad, Pune from the academic year 2008 - 09 subject to the following conditions:-

- 1) The intake capacity shall be 30 students.
- 2) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 3) The following deficiencies are pointed out by the UGC and it should be fulfilled within a period of 03 months:-
 - a) Details of 2 acre land earmarked for the Physiotherapy College or completed certificate of construction of 6,500 sq.ft. of college building for 1st year B.P.Th. should be submitted.
 - b) Eligible & Qualified Principal should be appointed.
 - c) Core subject books and journals should be made available.








(vi) Other:

- a. The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (format attached).
- b. For those UG / PG qualifications that are not yet recognized by the Central Govt., it shall be mandatory for the College to apply to the Central Council / Commission through Central Govt. and ensure that "Permitted" / "Not Recognized" qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year and no student shall be admitted in such courses.

(vii) Settlement of advance(s) / dues of any section of the University including affiliation fees if pending with the College and any other deficiency observed by any regulating authority, please submit within 01 (one) month, otherwise, no action will be taken on teacher's proposal for approval / PG Recognition received from your College.

Important Note:

- 1) This Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of State Government (as applicable). Further, if the permission is declined by the said authorities, this Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1st Year of the course until receipt of permission of State Government (as applicable).
- 2) The admission shall be done through the Competent Authorities only.
